ELIGIBILITY AND OTHER CONDITIONS FOR FILLING UP OF 04 (FOUR) POSTS OF DY. COMDT. (ARMOURER) IN ITBP ON DEPUTATION BASIS IN THE PAY MATRIX LEVEL-11 (RS. 67,700-20,8700/-)

The eligibility conditions attached to the post of Dy. Comdt. (Armourer) are as under:-

I :- By deputation,

II :- For ex-servicemen : deputation / re-employment:-

I) By deputation:-

Officers of Central Government Police organization or State Government Police Organization or Union Territories Police Organization or Central Armed Police Forces:-

(a) (i) holding analogous post on regular basis in the parent cadre or department; or

(ii) With five years service rendered after appointment to the post on regular basis in level 10 of the pay matrix (Rs. 56100-177500) or equivalent in the parent cadre or departments and have undergone Electrical or Mechanical Engineering (Assistant Inspector of Arms) course from Army or equivalent course from any other such department.

Note:1 The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note:2 The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinary not exceed three years and the Maximum age limit for appointment by deputation shall not be exceeding fifty two years as on the closing date of receipt of application.

II) Deputation / re-employment for Ex-Servicemen: -

The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having qualifications and experience prescribed for recruitment by deputation, shall also be considered and such persons shall be given deputation terms upto the date on which they are due for release from the Armed Force; thereafter they may be continued on re-employment basis.

2. Applications through proper channel of willing and suitable officers along-with their Bio-data in the prescribed proforma (enclosed) together with up-to-date APAR report (attested copies each page) for the last 05 years & vigilance clearance should reach "**Sr. Admn. Officer (Pers), Directorate General, ITBP, MHA/Govt. of India, Block-2, CGO Complex, Lodhi Road, New Delhi-110003**" within two months from the date of publication of the advertisement in Employment News/Rozgar Samachar. Officers once nominated will not be permitted to withdraw their candidature.
