OFFICE MEMORANDUM

Subject: Extension of referral facilities to CAPFs Hospital for the retired CAPFs personnel to bring them at par with facilities available for the pensioners who are residing in the CGHS covered areas-reg.

The undersigned is directed to refer to MHA O.M. No. 27011/55/2022-R&W dated 01.06.2023 on the subject above and to say that the matter was examined in consultation with Dte. of CGHS.

2. Accordingly, it is informed that as per the provisions contained in MoHFW OM dated 01.01.2015, any Government Medical officer/ Specialist can advice/refer a CGHS beneficiary to CGHS empaneled hospital. It is further informed that CGHS empaneled hospitals have entered MOA with CGHS to provide treatment to CGHS beneficiaries, as per terms and conditions of empanelment, which includes treatment on cashless basis to pensioner beneficiaries (including CAPF pensioners with CGHS cards), at CGHS rates, etc. The credit facility of such CGHS pensioner is provided by CGHS.

3. Further, CAPF pensioners who have opted for a Government health scheme, other than CGHS, can not be provided medical/referral facilities under CGHS because the medical facility is wholly sponsored by CAPF itself and the beneficiaries of such schemes are not the members of CGHS.

Sub: Extending powers to CMO In-charge of CRPF hospitals for referring to private recognized hospitals for specialized treatment to personnel of CRPF – reg.

The undersigned is directed to refer to this Ministry's OM no. S.11011/6/98-CGHS (P) dated 4/2/2008 on the above mentioned subject.

2. Hardships being faced by CAPF personnel in getting referral from Dy. Inspector General/Inspector General (Medical) due to various reasons, has been brought to the notice of this Ministry. The matter has been examined. With a view to alleviate the problems, it has been decided to relax the said provision and henceforth, CAPF personnel can get specialized treatment/investigations at CGHS empanelled private hospitals on the referral made by CMO In-charge of respective Battalions/other Hospitals of CRPF, provided he is a Specialist.
