12. Instruction for E-Tendering: -

- (i) Only e-offers submitted online through e-procurement portal will be considered.
- (ii) The bidders should keep checking the website for any addendum/corrigenda to the Notice/Bidding documents till the date of online submission of bids and the bidder should incorporate the same in his bid documents.
- (iii) Bids once submitted online cannot be resubmitted or withdrawn.
- (iv) Conditional bids and the bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
- (v) The bidders have to submit their bids online in electronic format with digital signature their bids proposed without digital signature will not be accepted. No proposal will be accepted in physical form.
- (vi) Bids will be opened online as per time schedule mentioned in table at para-06.
- (vii) Before submission of online bids, bidders must ensure that scanned copy of all the necessary documents have been uploaded with end.
- (viii) The department will not be responsible for delay in online submission due to any reasons.
- (ix) All the required information for bid must be filled and submitted online.
- (x) Bidders should get ready with the scanned copies of tender documents, EMD & Other documents as specified in the tender documents.
- (xi) The details of tender documents, EMD specified in the tender documents should be the same as submitted online (Scanned copies) otherwise tender will summarily be rejected.
